Horse shows having dates last year will retain first right of refusal on those date(s) through November 30<sup>th</sup>. As of December 1<sup>st</sup>, any date(s) previously held and not renewed, will become available to those requesting the date. New applications will be recorded on a first come first serve basis by the post mark on the envelope and must be received **90 days** in advance of the date.

Any person listed as a horse show manager must be a PSJ member and have an understanding of the PSJ rules and regulations. Our rules and regulations will be available on our website. Please review as there are changes.

Within 30 days after payment and application are received, horse shows dates will be listed on our website [www.psjshows.com](http://www.psjshows.com). Medal class descriptions as well as a membership application must be printed in the prize list. Prize lists must be mailed at least 45 days prior to the start of the show. Points must be mailed within one week of the completion of the show. Points received after that date may lose their sanctioning and will be fined. Fees will not be refunded.**
